## **BASIC INFORMATION**

#### Waiting time:

4 workdays (standard) / 3 days (express)

Documentation can be submitted from Monday to Friday.

All visa applications are submitted on the next business day after receipt.

Please note that application in express mode can be accepted to submission till 11 a.m.

The documents are submitted to the Chinese Visa Center at 39 Sienna Street in Warsaw. Anyone applying for a new visa who has not downloaded biometric data after December 16, 2019, or has a new passport issued after the first submission of biometric data, is required to appear in person at the visa center to submit them when applying for a new visa.

## VISA

### **Tourist visa:**

Single or double tourist visa (when applying, documents confirming the second entry must be presented), with each stay up to 30 days - requirements:

- Passport
- Copy/scan of the passport's photo page
- Photograph (x2)
- Visa application form
- Air ticket reservation
- Hotel reservation

#### **Business visa:**

Single, double, or multiple business visa (the condition is to have at least two used business visas in the passport), with each stay up to 30 days - requirements:

- Passport
- Copy/scan of the passport's photo page
- Photograph (x2)
- Visa application form
- Air ticket reservation
- Hotel reservation
  - Invitation from a Chinese company

Please send the set of files/scans of documents via the contact form for verification before making an appointment at the visa center.

## **ADDITIONAL INFORMATION**

As standard, it Is possible to obtain a 6-month visa which enables a traveler to 2 stays in China within this period – max. 30-day each. It is also possible to obtain a 12-month visa, but it has to be documented at the consulate that the applicant has already used a minimum of 3 business visas to China. For business visas, it is important that the invitations contain information about the exact dates of arrival and departure from China, and the information who covers the travel costs. The invitation must be on company's letterhead and contain the exact address and contact details in China.

The assistance of Weco-Travel includes the verification of documents, assistance during a visit to the visa center, taking over the payment as well as collecting and sending the passport with the visa.

#### Important:

Please check the technical condition of your passport and the number of blank pages. The passport must not have any technical damages (please check the condition of the first photo page of the passport).
